MINUTES OF THE FIRST REGULAR MONTHLY MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF MADISON, MISSISSIPPI

October 3, 2017

INTRODUCTION AND ATTENDANCE

The first regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, October 3, 2017 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. Those present were Mayor Mary Hawkins Butler, Aldermen Tawanna Tatum, Patricia Peeler, Ken Jacobs, Steve Hickok, Mike Hudgins, Guy Bowering, and Warren Strain, City Attorney Dale Danks, City Clerk/Director of Finance and Administration Susan Crandall, and Chief Deputy City Clerk Lisa Winstead.

Mayor Hawkins Butler called the meeting to order and after a Prayer led by Alderman Jacobs and the Pledge of Allegiance led by Alderman Tatum, the meeting proceeded as follows:

Mayor Hawkins Butler welcomed Mr. Dale Danks and his law firm, Danks, Miller & Cory as the new City Attorney.

Alderman Tatum seconded the motion and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried.

SUNDIAL SUBDIVISION CHRISTMAS DISPLAY

Mayor Hawkins Butler opened the floor for discussion regarding the Richardson Family's annual Christmas display at 219 Sundial Road. Mr. and Mrs. Richardson were present at the meeting.

The Mayor recognized Celie and Eddy Edwards of 238 Sundial Road who asked to make a presentation to the Mayor and Board regarding their opposition to the display. Mayor Hawkins Butler allowed him 20 minutes to address the Board.

Mr. Edwards first stated that his attendance at the meeting was not as a representative of the homeowners association, but rather as an individual homeowner having resided at this location for over 31 years. Also in attendance at the meeting, in opposition of the display, were Ralph and Millie Didlake and Charles and Jeannie Williford. Mr. Edwards explained to the Mayor and Board that he and other homeowners feel this light display has become too large, is an annoyance and nuisance to the community and is prohibited by subdivision overlay, homeowners association, City and state ordinances.

At the conclusion of Mr. Edwards' presentation, Mayor Hawkins Butler asked if there were others present who would like to speak to the matter. Dr. Ralph Didlake commented that the pollution caused by exhaust fumes and the blockage of entrances

and exits due to excessive numbers of vehicles constitutes a public safety and health hazard to the community. There were no other person(s) who wished to speak to the matter.

Brief discussion was held during which time City Attorney Danks advised that the presentation was a position of public comment and no action should be taken regarding the matter until after the Board had sufficient time to give consideration to the matter. At this time, Alderman Strain made a motion to take the matter under advisement until the next regularly scheduled Board meeting. Alderman Tatum seconded the motion and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried. A copy of the Edwards' presentation is attached hereto and incorporated herein as **Exhibit L.** In addition, an outline of the Police Department's traffic plan provided by Lt. Stephen Patrick is attached as **Exhibit M.**

EXECUTIVE SESSION

At this time, Mayor Mary Hawkins Butler requested to enter into a Closed Session to determine if an Executive Session would be appropriate regarding a matter of potential litigation. Alderman Strain made the motion, seconded by Alderman Bowering and unanimously approved by all Board members. The Mayor declared the motion carried and requested that the public vacate the room.

After brief discussion, it was determined that an Executive Session would be appropriate for discussion of a matter of potential litigation. The public was invited to return to the room to hear the motion as follows: Alderman Strain moved to go into Executive Session for the purpose of discussing a matter of potential litigation and personnel issues. Alderman Jacobs seconded the motion. The vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried and once again asked that the room be vacated.

Mayor Hawkins Butler stated that Mr. and Mrs. Edwards are both attorneys and have insinuated that they will consider litigation and an injunction to stop the Christmas light display in Sundial. It was noted that the Sundial Homeowners Association has not taken a stand against the issue and only four (4) homeowners in opposition to the display were represented at the meeting.

After discussion with the Fire and Police Chiefs regarding emergency and traffic issues, and consideration of possible alternate locations for the display, City Attorney Danks recommended that the matter be tabled and no action taken at this time. Alderman Strain made the motion to table discussion regarding potential litigation. The motion was seconded by Alderman Jacobs and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried.

With discussion concluded, Mayor Hawkins Butler asked for a motion to end the Executive Session and invite the public to return to the meeting room to hear the action of the Board taken during Executive Session. Alderman Bowering made the motion, to end the Executive Session, seconded by Alderman Hickok and unanimously approved by all Board members. Mayor Hawkins Butler declared the motion carried and the public returned to the meeting room. The action of the Board was reiterated as follows:

Alderman Strain made the motion to table discussion regarding potential litigation. The motion was seconded by Alderman Jacobs and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried.

With no further business for discussion, the motion was duly made, seconded and unanimously carried to adjourn the meeting. Mayor Hawkins Butler declared the meeting adjourned.
