# MINUTES OF THE FIRST REGULAR MONTHLY MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF MADISON, MISSISSIPPI

February 7, 2017

#### **INTRODUCTION AND ATTENDANCE**

The first regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, February 7, 2017 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. He stated that all matters have been resolved and recommended approval of the plats as presented.

Alderman Jacobs made the motion to approve the aforementioned plat as presented by Mr. Wages. Alderman Bowering seconded the motion, the vote was unanimous in favor of approval and Mayor Hawkins Butler declared the motion carried.
