# MINUTES OF THE FIRST REGULAR MONTHLY MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF MADISON, MISSISSIPPI

October 2, 2018

#### INTRODUCTION AND ATTENDANCE

The first regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, October 2, 2018 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. Those present were Mayor Mary Hawkins Butler, Aldermen Tawanna Tatum, Ken Jacobs, Steve Hickok, Mike Hudgins, Guy Bowering, and Warren Strain, City Attorney Dale Danks, and City Clerk/Director of Finance and Administration Susan Crandall. Alderman Patricia Peeler was absent.

Mayor Hawkins Butler called the meeting to order. She welcomed Mr. Bill Franks, President of the Classic Cruisers, who addressed the Board and the public regarding the upcoming 2018 Scarecrow Cruise and Car Show to be held September 19-21, 2018. He also honored Mr. Tom Ward, former member of the organization who was very instrumental in this event.

There was a presentation to the City by Senator Walter Michel and Representative Corey Wilson for being named The Most Successful City in Mississippi.

Alderman Tatum seconded the motion to approve the Consent Agenda and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried.

# <u>PUBLIC HEARING FOR CLEANING OF PRIVATE PROPERTY - 320 ST. IVES DRIVE- Continued</u>

Mayor Hawkins Butler opened the Public Hearing from discussion regarding the cleaning of this property located at 320 St. Ives Drive. Mr. Samuel Williford, Attorney addressed the Board stating that a conservatorship was being formed for the property owner, Mr. Dan Hanchey, who has moved to Florida, and that the house will be listed for sale. The requested work to clean the property has been accomplished at this time. With no further discussion, Alderman Bowering made a motion to continue the Public Hearing, seconded by Alderman Strain and unanimously approved. Mayor Hawkins Butler declared the motion carried.

RESOLUTION AUTHORIZING AND DIRECTING THE ISSUANCE OF GENERAL OBLIGATION UTILITY BONDS, SERIES 2018, OF THE CITY OF MISSISSIPPI IN THE PRINCIPAL AMOUNT OF ONE MILLION SEVEN HUNDRED THOUSAND DOLLARS (\$1,700,000) TO FINANCE THE ACQUISITION OF SEWAGE SYSTEM ASSETS FOR THE PURPOSE OF IMPROVING AND EXTENDING THE MUNICIPALITY'S SEWAGE SYSTEM AND FOR RELATED **PURPOSES**; PRESCRIBING THE FORM AND INCIDENTS OF SAID BONDS; PROVIDING FOR THE LEVY OF TAXES FOR THE PAYMENT THEREOF; PROVIDING FOR THE SALE OF SAID BONDS; MAKING PROVISION FOR MAINTAINING THE TAX-EXEMPT STATUS OF SAID BONDS; APPROVING AND AUTHORIZING THE DISTRIBUTION OF A PRELIMINARY OFFICIAL STATEMENT; AUTHORIZING THE EXECUTION AND DISTRIBUTION OF AN OFFICIAL STATEMENT PERTAINING TO THE SALE SAID BONDS; AUTHORIZING THE EXECUTION OF A CONTINUING DISCLOSURE CERTIFICATE PERTAINING TO SAID BONDS; ACKNOWLEDGING AND AUTHORIZING THE EXECUTION OF POST ISSUANCE COMPLIANCE PROCEDURES; AND FOR RELATED PURPOSES - Adopted

After brief discussion, the motion was made by Alderman Hickok to adopt the abovenamed Resolution as presented. Alderman Jacobs seconded the motion and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried. A copy of this Resolution is on file with the City Clerk/Director of Finance and Administration.

## AIRPORT HANGAR REPAIRS - Approved

Discussion was held regarding the authorization for, and ratification of, the purchase of replacement stack doors on the airport hangers damaged during the August 17, 2018 tornadic storm, from Horton, Inc., based on sole source certification and certification of need for emergency repair to restore hanger's immediate usefulness and to prevent further damage. Certifications and a proclamation were entered into the minutes as **Exhibit S.** 

# APPEAL REQUEST FOR PUBLIC HEARING - JONATHAN STILL - Date Set

Pursuant to the written request of Jonathan Still regarding the denial of his home occupation request at 100 Fontanelle Boulevard, the motion was made by Alderman

Strain to set a hearing date of November 6, 2018 for this matter to be heard before the Board and the public. Alderman Hudgins seconded the motion and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried. A copy of the appeal request is attached hereto and incorporated herein as **Exhibit T**.

#### EXECUTIVE SESSION - PERSONNEL MATTERS

Mayor Mary Hawkins Butler requested to enter into a Closed Session to determine if an Executive Session would be appropriate regarding several personnel matters. Alderman Hickok made the motion, seconded by Alderman Strain and unanimously approved by all Board members. The Mayor declared the motion carried and requested that the public vacate the room.

After brief discussion, it was determined that an Executive Session would be appropriate for discussion of personnel matters. The public was invited to return to the room to hear the motion as follows: Alderman Hickok moved to go into Executive Session for the purpose of discussing personnel matters. Alderman Strain seconded the motion. The vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried and once again asked that the room be vacated.

Discussion was held with regard to the personnel matters and upon conclusion, Alderman Bowering moved to approve the transfer of Ken Wilbanks from the Permits and Codes Department to the Street Department, seconded by Alderman Jacobs and unanimously approved. The Mayor declared the motion carried.

In addition, Alderman Jacobs made a motion to transfer Wesley Gannon from the Street Department to the Arts Center, seconded by Alderman Strain. The vote was unanimously approved and Mayor Hawkins Butler declared the motion carried.

The motion to adjourn the Executive Session was made by Alderman Bowering, seconded by Alderman Strain and unanimously approved by all Alderman. Mayor Hawkins Butler declared the motion carried.

With no further business for discussion, Mayor Hawkins Butler asked for a motion to declare the Board meeting adjourned. Alderman Jacobs made the motion, seconded by Alderman Hudgins and unanimously approved by all Board members. Mayor Hawkins Butler declared the motion carried and the meeting was adjourned.
