INTRODUCTION AND ATTENDANCE

The first regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, November 1, 2016 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. Those present were Mayor Mary Hawkins Butler, Aldermen Tawanna Tatum, Patricia Peeler, Ken Jacobs, Mike Hudgins, Guy Bowering, and Warren Strain, City Attorney John Hedglin, City Clerk/Director of Finance and Administration Susan Crandall and Chief Deputy City Clerk Lisa Winstead. Alderman Steve Hickok was absent.

Mayor Hawkins Butler called the meeting to order. Special recognition was given to members of Boy Scout Troop #164 of Parkway Hills Methodist Church who were in attendance at the meeting in partial fulfillment of requirements necessary to earn their Citizenship in the Community badges. Attending the meeting with them was Scout Master Chuck Dearman and Assistant Scout Master Rick Tice.

<u>DISCUSSION AND POSSIBLE ACTION REGARDING AN ORDINANCE TO PROHIBIT HAZARDOUS AND DESTRUCTIVE CONSTRUCTION PRACTICES DURING THE INSTALLATION OF PUBLIC UTILITIES - Adopted</u>

The Mayor initiated discussion regarding recent problems concerning destruction of public utilities during construction projects involving City right-of-way. City Attorney John Hedglin was asked to speak to the Board concerning the proposed Ordinance. Mr. Hedglin explained that this Ordinance would make contractors, utility companies, and other entities accountable for the destruction of public utilities and subject to possible penalty if they are found to be in violation of the Ordinance. In addition, it would give the Public Works Director the authority to issue a stop work order on any project necessary. Public Works Director Chad Wages confirmed that this has been an ongoing and costly problem for the City.

The motion was made by Alderman Strain to adopt this Ordinance prohibiting hazardous and destructive construction practices as presented. Alderman Bowering seconded the motion and the vote was unanimous approved by all Alderman present. Mayor Hawkins Butler declared the motion carried. With no further business for discussion, Mayor Hawkins Butler declared the meeting adjourned.
