INTRODUCTION AND ATTENDANCE

A Special Called Meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held at 1:00 p.m. on Monday, February 22, 2021 in the Municipal Courtroom at the Madison Justice Complex in Madison, Mississippi.

Notice of the date, time, location and specific subject matter of business to be acted upon was given to each alderman at least three hours prior to the time fixed for the meeting, pursuant to Miss. Code Section 21-3-21.

Those present in in the Courtroom were Mayor Mary Hawkins Butler, Aldermen Tawanna Tatum, Ken Jacobs, Paul Tankersley, and Guy Bowering, City Clerk/Director of Finance and Administration Susan Crandall, and Chief Deputy City Clerk Lisa Winstead. Aldermen Patricia Peeler, Mike Hudgins and Sandra Strain and City Attorney Chelsea Brannon were present by phone.

The City Clerk presented the Meeting Notice and fully executed Waiver of Notification. A copy of the Meeting Notice and Waiver of Notification is attached hereto and incorporated herein as **Exhibits A and B**, respectively.

Mayor Hawkins Butler called the meeting to order and after a Prayer led by Alderman Jacobs the meeting proceeded as follows:

Alderman Bowering made the motion, seconded by Alderman Tatum and unanimously approved by all Board members. Mayor Hawkins Butler declared the motion carried.
