# MINUTES OF THE FIRST REGULAR MONTHLY MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF MADISON, MISSISSIPPI

February 7, 2023

### INTRODUCTION AND ATTENDANCE

The first regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, February 7, 2023 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. Those present in in the Courtroom were Mayor Mary Hawkins Butler, Aldermen Sandra Strain, Tawanna Tatum, Janie Jarvis, Paul Tankersley, Mike Hudgins, and Guy Bowering, City Attorney Chelsea Brannon, City Clerk/Director of Finance and Administration Susan Crandall, and Chief Deputy City Clerk Lisa Winstead. Alderman Pat Peeler was absent.

Mayor Hawkins Butler called the meeting to order and after a prayer led by Alderman Hudgins and the Pledge of Allegiance led by Alderman Bowering, the meeting proceeded as follows:

Alderman Jarvis seconded the motion to approve the Consent Agenda and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried.

# PUBLIC HEARING FOR CLEANING OF PRIVATE PROPERTY – 201 FOREST LAKE DRIVE – Resolution Adopted

Mayor Hawkins Butler opened the Public Hearing for discussion regarding the condition of residential property located at 201 Forest Lake Drive in Annandale Subdivision. She called upon Code Enforcement Officer Steve Greenough who explained that the house is currently vacant and in complete disrepair. He stated that the property is currently owned by a bank and that he had no recent communication with the owner or real estate agent. He asked the Board to consider adoption of a Resolution to have the property cleaned.

There were several neighboring resident present at the meeting who spoke to the matter:

Lynn Nelson, President of the Annandale Homeowners Association (HOA) presented an email she received from the property manager regarding foreclosure and a balance owed on the property. A copy of that email is attached hereto as **Exhibit W**. Ms. Nelson added that the HOA is currently fining the property owners \$25.00 per week for covenant violations.

Jere Moak of 202 Forest Lake, stated that the lives across the street from this property and that she is concerned with the condition of the property with its foundation and landscaping issues and with the effect it has on surrounding property values. Mr. Jim Files stated that he lives next door to Ms. Moak and has similar concerns.

Ms. Sylvia Pooley of 194 Forest Lake stated that she had entered the home on one occasion and noted the deplorable conditions with animals living inside in addition of the landscaping and foundation issues.

At the conclusion of comments, Mayor Hawkins Butler declared the Public Hearing closed and asked for a motion. Alderman Bowering made the motion to approve adoption of a Resolution to authorize the City to have the property cleaned should the owners not do so themselves. The motion was seconded by Alderman Strain and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried. A copy of this Resolution is attached hereto and incorporated herein as **Exhibit X**.

With no further business for discussion, Mayor Hawkins Butler asked for a motion to declare the meeting adjourned. Alderman Jarvis made the motion, seconded by Alderman Hudgins and unanimously approved by all Alderman. Mayor Hawkins Butler declared the motion carried and the meeting was adjourned.
