FINAL PLAT APPROVAL - WHITTINGTON, PHASE 3 - Approved

With regard to the final plat for Whittington, Phase 3, Assistant Public Works Director Dexter Shelby explained that all conditions of the staff notes had been met and he recommended approval of the final plat. The motion was made by Alderman Tatum to grant final plat approval, seconded by Alderman Jacobs and unanimously approved by all Alderman. Mayor Hawkins Butler declared the motion carried.

FINAL PLAT APPROVAL - THE VILLAGES OF MADISON - Approved

Mayor Hawkins Butler recused herself from discussion regarding The Villages of Madison and after asking Mayor Pro Tempore to preside, she left the meeting. Mayor Pro Tempore Bowering asked Assistant Public Works Director Dexter Shelby if all matters pertaining to the final plat approval of The Villages were in order. Mr. Shelby recommended approval of the final plat contingent upon resolution of all staff notes with particular regard to drainage issues. Alderman Hudgins made the motion to grant final plat approval of The Village with the contingencies as noted by Mr. Shelby. Alderman Strain seconded the motion and the vote was unanimous in favor of approval. Mayor Pro Tempore Bowering declared the motion carried.

With no further business for discussion, Mayor Pro Tempore Bowering asked for a motion to declare the meeting adjourned. Alderman Tatum made the motion to adjourn, seconded by Alderman Peeler and unanimously approved. Mayor Pro Tempore Bowering declared the motion carried and the meeting adjourned.
