The first regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, March 5, 2019 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. ENVIRONMENT AND DESIGN DEPARTMENT – THE LANDING AT CALUMET, PART 1, ARCHITECTURAL APPROVAL AND BUILDING PERMIT - Approved

Director of Environment and Design Alan Hoops presented the request of Prosperity Holdings, LLC for the architectural approval and permission to issue a building permit for office space to be located at Calumet Office Park on Old Canton Road. After brief discussion and review of the architectural rendering, Alderman Strain made the motion to grant approval of the building design and to authorize the issuance of a building permit contingent upon the resolution of all details as outlined in the staff notes and working out details on the site plan. Alderman Jacobs seconded the motion and the vote was unanimous in favor of approval Mayor Hawkins Butler declared the motion carried.

PUBLIC HEARING FOR CLEANING OF PRIVATE PROPERTY - Continued

Mayor Hawkins Butler opened the Public Hearing for continuation of discussion regarding the cleaning of private property located at 3117 W. Tidewater Lane. She stated that Code Enforcement Officer Miriam Ethridge had reported good progress and improvements being made at the home and asked for a motion to continue the public hearing. There was no one present from the public to address the matter. Alderman Hudgins made the motion to continue the hearing. Alderman Tatum seconded the

motion. The vote was unanimous in favor of approval and Mayor Hawkins Butler declared the motion carried.
