INTRODUCTION AND ATTENDANCE

The first regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, April 5, 2022 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. AN ORDER BY THE BOARD OF ALDERMEN, PURSUANT TO SENATE BILL 2095, 2022 REGULAR SESSION OF THE MISSISSIPPI LEGISLATURE, EXERCISING THE RIGHT OF LOCAL GOVERNMENT OPTION TO OPT OUT OF THE "MISSISSIPPI MEDICAL CANNABIS ACT" AND FOR RELATED PURPOSES - Approved

Mayor Mary Hawkins Butler initiated discussion regarding the aforementioned Order Exercising the Right of Local Government Option to Opt Out of the "Mississippi Medical Cannabis Act and asked if there was anyone present who would like to speak to regarding the matter.
