INTRODUCTION AND ATTENDANCE

The second regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, June 19, 2018 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. Those present were Mayor Mary Hawkins Butler, Aldermen Tawanna Tatum, Patricia Peeler, Ken Jacobs, Steve Hickok, Mike Hudgins, Guy Bowering, and Warren Strain. City Attorney Dale Danks, City Clerk/Director of Finance and Administration Susan Crandall and Chief Deputy City Clerk Lisa Winstead.

Mayor Hawkins Butler called the meeting to order. After the invocation led by Alderman Ken Jacobs and the Pledge of Allegiance led by Alderman Warren Strain, the meeting proceeded as follows:

Alderman Strain seconded the motion to approve the Consent Agenda and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried.

<u>DEPARTMENT OF COMMUNITY DEVELOPMENT – VARIANCE, GAIL SLAUGHTER</u> - Approved

Community Development Director Kianca Stringfellow presented the request of Gail Slaughter for Variance Application #2018-005V to decrease the required size of a lot from 1 acre to .094 acre. She explained that the properly is located just south of 1286 North Livingston Road in the North Livingston Overlay District (Parcel number 071B-03-013/00/0, Zoned RE-A), and was part of property taken by the County to widen the road. Ms. Slaughter is asking for the variance in order to build a home. It was noted that the Planning and Zoning Commission recommended approval of this variance request. Alderman Hudgins made a motion to grant approval as requested, seconded by Alderman Bowering. The vote was unanimous in favor of approval and Mayor Hawkins Butler declared the motion carried. Documentation relevant to this request is attached hereto and incorporated herein as **Exhibit T**.

<u>DEPARTMENT OF COMMUNITY DEVELOPMENT - SITE PLAN, LA GRANGE</u> (EVENT BARN) - Approved

Community Development Director Kianca Stringfellow presented the request of Karla Collins for site plan approval of La Grange Event Barn to be located on Crawford Street south of the Madison Justice Complex. Ms. Collins previously requested approval, but her application expired. She is now asking for approval of the site plan to construct a 3,128 square foot events venue. Ms. Stringfellow noted that the architectural design for the building had previously been approved and that the Planning and Zoning Commission recommends approval of the site plan. Alderman Tatum made the motion to grant approval of the site plan request as presented, seconded by Alderman Strain. The vote was unanimous in favor of approval and Mayor Hawkins Butler declared the motion carried. Documentation relevant to this request is attached hereto and incorporated herein as **Exhibit U**.

DEPARTMENT OF COMMUNITY DEVELOPMENT - SITE PLAN, BURGER KING RESTAURANT REBUILD - Approved

Community Development Director Kianca Stringfellow presented the request of GPS Hospitality (Cole Cooper) for site plan approval to rebuild the Burger King Restaurant at 1874 Main Street. Architect David Ruiz of Fusion Architecture was present at the meeting and explained that demolition of the existing structure is expected to begin in July 2018 with completion of the rebuilding projected for November 2018. The Planning and Zoning Commission recommended approval of this site plan. Alderman Strain made the motion to approve the site plan for rebuild, seconded by Alderman Jacobs, and unanimously approved by all Aldermen. Mayor Hawkins Butler declared the motion carried. Documentation relevant to this request is attached hereto and incorporated herein as **Exhibit V**.

PUBLIC HEARING FOR CLEANING OF PRIVATE PROPERTIES

Mayor Hawkins Butler declared the Public Hearings open for discussion regarding the Cleaning of Private Properties as outlined below. It was noted by Code Enforcement Official Ken Wilbanks that certified letters had been mailed to all property owners and all properties had been properly posted with regard to the Hearings. Copies of all Resolutions Pertaining to the Cleaning of Private Property for these parcels are attached hereto and incorporated herein as **Exhibit W**.

Tullio, LLC - Parcel No. 072C-06A-003/10.00

Craig Panter, legal counsel for the property owner (Ambrosino family) explained that this property had been cut and cleaned. Ken Wilbanks confirmed that the property had been cut, but not edged. Mayor Hawkins Butler asked if the owners would edge the property to further enhance the clean-up. The owners stated that they would be agreeable and the matter was tabled. No resolution was adopted at this time.

Galleria Parkway, LLC - Parcel No. 072C-06A-003/01.00

Mr. Panter stated that this parcel is now owned by the State of Mississippi as the results of a 2012 tax sale. Mr. Wilbanks indicated that the property had not been properly cut and cleaned. Alderman Tatum made a motion to adopt a Resolution to allow the City to have the property cleaned. Alderman Strain seconded the motion and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried.

GEN Properties, LLC - Parcel No. 072C-06A-003/11.00

Mr. Panter stated that this parcel has been properly cut and cleaned. The motion was made by Alderman Strain to table the item pending inspection of the property. Alderman Tatum seconded the motion and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried.

After brief discussion, Alderman Strain made the motion to take these properties under advisement pending inspection. Alderman Tatum seconded the motion and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried.

Cedarcrest Properties, LLC - Parcel No. 072C-06A-005/03/00

Mr. Wilbanks stated that this property had not been cut or cleaned. The motion was made by Alderman Bowering to adopt a Resolution to have the property cleaned. Alderman Strain seconded the motion and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried.

At this time, Mayor Hawkins Butler asked if there were any comments from the public with regard to the remaining properties listed below. There were none and it was recommended by Mr. Wilbanks that the adoption of cleaning be considered to have these properties cleaned. Alderman Tatum made the motion to adopt resolution to have each of these parcels cleaned, seconded by Alderman Jacobs. The vote was unanimous in favor of approval and Mayor Hawkins Butler declared the motion carried.
