MINUTES OF THE FIRST REGULAR MONTHLY MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF MADISON, MISSISSIPPI

June 4, 2019

INTRODUCTION AND ATTENDANCE

The first regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, June 4, 2019 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. Those present were Mayor Mary Hawkins Butler, Aldermen Tawanna Tatum, Patricia Peeler, Ken Jacobs, Steve Hickok, Mike Hudgins, Guy Bowering, and Warren Strain, City Attorney Dale Danks, City Clerk/Director of Finance and Administration Susan Crandall and Chief Deputy City Clerk Lisa Winstead.

Mayor Hawkins Butler called the meeting to order. After a prayer led by Alderman Jacobs and the Pledge of Allegiance led by Alderman Bowering, the meeting proceeded as follows:

Alderman Bowering seconded the motion to approve the Consent Agenda and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried.

DEPARTMENT OF ENVIRONMENT AND DESIGN

On behalf of Developer Alex Ross and Architect Daniel Wooldridge, Director of Environment and Design Alan Hoops presented the architectural rendering for an office building to be located on Lot 17, Waterford Square. After brief review, a motion was made by Alderman Strain to grant approval of the architectural rendering and authorize permission to issue the building permit. Alderman Jacobs seconded the motion which was unanimously approved. Mayor Hawkins Butler declared the motion carried.

PUBLIC HEARING FOR CLEANING OF PRIVATE PROPERTY, 301 MOCKINGBIRD

Mayor Hawkins Butler opened the Public Hearing for discussion regarding the condition of private property located at 301 Mockingbird Lane. PUBLIC WORKS DEPARTMENT - SMOKE TESTING

In other business, Mayor Hawkins Butler addressed the issue of smoke testing the City's water and sewer lines to check for infiltration/leakage. It was determined that City Attorney Dale Danks had checked with the State Auditor's office and would also secure an Attorney General's opinion with regard to the matter as a provision of service. Once this opinion is received, the decision will be made to how to proceed.

PROPERTY CLEANING - 715 HIGHLEADON PLACE

Mayor Hawkins Butler presented quotes received for the demolition and cleaning of the property and structure located at 715 Highleadon Place pursuant to the adoption of a cleaning resolution. After brief discussion, the motion was made by Alderman Peeler to authorize the City counsel to evaluate and make a determination as to the lowest and best bidder for the project. The motion was seconded by Alderman Tatum and unanimously approved. Mayor Hawkins Butler declared the motion carried.

EXECUTIVE SESSION

Mayor Mary Hawkins Butler requested to enter into a Closed Session to determine if an Executive Session would be appropriate regarding discussion of matters of ongoing litigation, possible litigation and the purchase of property. Alderman Strain made the motion, seconded by Alderman Bowering and unanimously approved by all Board members. The Mayor declared the motion carried and requested that the public vacate the room.

After brief discussion, it was determined that an Executive Session would be appropriate for discussion of matters of ongoing litigation, possible litigation and the

purchase of property. The public was invited to return to the room to hear the motion as follows: Alderman Bowering made the motion to go into Executive Session for the purpose of discussion of matters of ongoing litigation, possible litigation and the purchase of property. Alderman Jacobs seconded the motion. The vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried and once again asked that the room be vacated.

General discussion was held concerning matters of ongoing litigation, possible litigation and the purchase of property. As part of this discussion, the motion was made by Alderman Bowering to authorize the City of Madison to pay the sum of \$10,000.00 as full and final settlement of claims in the matters: United States District Court, Mississippi Southern District, Cause Number 3:18-cv-00018-LG-RHW, and the suit filed in the Circuit Court of Madison County, Cause Number CI 2019-0062, and authorizing the Mayor to sign any settlement documents in furtherance of the dismissal of these claims. Alderman Hickok seconded the motion and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried.

With no further business for discussion, Mayor Hawkins Butler asked for a motion to end the Executive Session. Alderman Strain made the motion, seconded by Alderman Bowering and unanimously approved by all Board members. Mayor Hawkins Butler declared the motion carried.

HOY ROAD IMPROVEMENT PROJECT - CE&I Bids Rejected

After brief discussion, a motion was made by Alderman Hickok to reject all CE&I bids received for the Hoy Road improvements project. Alderman Strain seconded the motion and the vote was unanimous in favor of approval. A copy of the bid tabulation sheet is attached hereto and incorporated herein as **Exhibit X**.

QUOTES FOR PROPERTY CLEANING - 715 HIGHLEADON PLACE

After brief discussion, the motion was made by Alderman Strain to accept all quotes received for the cleaning and demolition of the property and structure located at 715 Highleadon Place and to award the project to M&M Services, Inc. based on requirements as set forth in the Cleaning Resolution adopted on May 21, 2019. Alderman Peeler seconded the motion. The vote was unanimous in favor of approval and the Mayor declared the motion carried. With no further business for discussion, the motion was duly made by Alderman Bowering, seconded by Alderman Hudgins and unanimously carried to adjourn the meeting. Mayor Hawkins Butler declared the meeting adjourned.
