# MINUTES OF THE FIRST REGULAR MONTHLY MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF MADISON, MISSISSIPPI

June 4, 2024

### INTRODUCTION AND ATTENDANCE

The first regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, June 4, 2024 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. # PUBLIC HEARINGS FOR CLEANING OF PRIVATE PROPERTY - Resolutions Adopted

Mayor Hawkins Butler declared the Public Hearings opened for discussion regarding the cleaning of private properties located at 245 Kiowa Drive and 269 Woodland Brook Drive.

<u>245 Kiowa Drive</u> – Code Enforcement Officer Steve Greenough stated that this property is in foreclosure and owned by a mortgage company. He recommended that the Board adopt a Resolution to have the property cleaned. Based on this recommendation, Alderman Hudgins made the motion to adopt the cleaning Resolution, seconded by Alderman Tankersley, and unanimously approved by all Alderman. Mayor Hawkins Butler declared the motion carried.

<u>269 Woodland Brook Drive</u> — Mr. Greenough stated that the property needs mowing and that the owner, Ms. Jane Nguyen has currently taken care of the mowing and pledged to continue to do so. He recommended that a cleaning Resolution be adopted to authorize the City to have the property cleaned should she not continue to do so. Ms. Nguyen was present at the meeting and in agreement with these statements. The motion was made by Alderman Tankersley to adopt the cleaning Resolution, seconded by Alderman Peeler, and unanimously approved. Mayor Hawkins Butler declared the motion carried.

# RESOLUTION ADOPTING SERVICES AND FACILITIES PLAN FOR ANNEXATION AREA - Adopted
