June 6, 2023

INTRODUCTION AND ATTENDANCE

The first regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, June 6, 2023 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. Those present in in the Courtroom were Mayor Pro Tempore Guy Bowering, Aldermen Sandra Strain, Tawanna Tatum, Janie Jarvis, Paul Tankersley, and Mike Hudgins, City Attorney Chelsea Brannon, City Clerk/Director of Finance and Administration Susan Crandall, and Chief Deputy City Clerk Lisa Winstead. Mayor Mary Hawkins Butler and Alderman Pat Peeler were both absent.

Mayor Pro Tempore Bowering called the meeting to order and after a prayer led by Alderman Tankersley and the Pledge of Allegiance led by Alderman Strain, the meeting proceeded as follows:

CANDIDATE FOR MADISON COUNTY CONSTABLE

Mayor Pro Tempore Bowering welcomed Mr. Richard "Taco" Johnson to the Board meeting. He introduced himself to the Board and audience as a candidate running for the office of Madison County Constable, District 3.

MAYOR'S YOUTH COUNCIL SCHOLARSHIP PRESENTATION

Director of Community Partners Amy Cummins recognized Miss Margaret Ann Henderson as the winner of the Mayor's Youth Council scholarship and commended her for this accomplishment.

MS. MELCENIA GILBERT – HARRIS LANE

Ms. Melcenia Gilbert, a resident of Harris Lane was present regarding mowing of the easement along Harris Lane. She stated that the easement had not been mowed in quite some time. Public Works Operations Manager Pete Vozzo explained that the issue was due to miscommunication between the City and new mowing contractor. He stated that this location was inadvertently not included in the contract, but from this point forward would be mowed from the easement to the ditch by City employees on a regular basis of every two weeks or more often as necessary.

PUBLIC HEARINGS FOR CLEANING OF PRIVATE PROPERTIES

1112 Benbrook Drive - Tabled

Mayor Pro Tempore Bowering declared the Public Hearing open for discussion concerning private property located at 1112 Benbrook Drive. Code Enforcement Officer Steve Greenough explained that the property owners had been notified, but no response Once the property was posted for Public Hearing, family members addressed the issues. However, Mr. Greenough asked for adoption of a cleaning Resolution should the matter arise and again and action is needed. Ms. Barbara Wann of 104 Hunt's Lane in Brandon, Mississippi was present at the meeting. She explained that the property belongs to two of her sister's who are unable to care for themselves or properly maintain the property. Additional family members present at the meeting were Stephen Waldrup and Christy Palmer. After brief discussion, the Public Hearing was closed and a motion was made by Alderman Hudgins to table the matter allowing an opportunity for Mr. Greenough to further discuss the matter with Ms. Wann and City The motion was seconded by Alderman Jarvis and Attorney Chelsea Brannon. unanimously approved by all Aldermen.

1037 North Azalea Drive – Resolution Adopted

Mayor Pro Tempore Bowering declared the Public Hearing open for discussion concerning private property located at 1037 North Azalea Drive. Code Enforcement Officer Steve Greenough explained that he had spoken to the property owners earlier in the day, but that they were unable to attend the meeting. However, they did provide an updated mailing address for further notices. Mr. Greenough asked for adoption of a cleaning Resolution. The Public Hearing was closed and a motion was made by Alderman Jarvis to adopt a cleaning Resolution to provide the City with authority to clean the property should the owners not do so themselves. Alderman Tatum seconded the motion. The vote was unanimous in favor of approval and the motion was declared carried. This Resolution is attached hereto as **Exhibit Z**.

176 St. Augustine Drive - Resolution Adopted

Mayor Pro Tempore Bowering declared the Public Hearing open for discussion concerning private property located at 176 St. Augustine Drive. Code Enforcement Officer Steve Greenough explained that this property is owned by Rebecca Ezell who currently resides in Wesson, MS and is unable to attend the meeting. He explained that Ms. Ezell is trying to sell the property to a relative, but he would like to ask for adoption of a cleaning Resolution to address any issues which may arise. The Public Hearing was closed and a motion was made by Alderman Jarvis to adopt a cleaning Resolution to provide the City with authority to clean the property should the owners not do so. Alderman Tankersley seconded the motion. The vote was unanimous in favor of approval and the motion was declared carried. This Resolution is attached hereto as **Exhibit AA**.

256 Sheryl Drive - Tabled

Mayor Pro Tempore Bowering declared the Public Hearing open for discussion concerning private property located at 256 Sheryl Drive. Code Enforcement Officer Steve Greenough explained that the property owners had been notified, but no response was received. Once the property was posted for Public Hearing, family members addressed the issues. However, Mr. Greenough asked for adoption of a cleaning Resolution should the matter arise and again and action is needed. Ms. Barbara Wann of 104 Hunt's Lane, Brandon, Mississippi was present at the meeting. She explained that the property belongs the same two sisters mentioned above and asked that this public hearing be tabled as well. Additional family members present at the meeting were Stephen Waldrup and Christy Palmer. The Public Hearing was closed and after brief discussion, the motion was made by Alderman Hudgins to table the matter allowing an opportunity for Mr. Greenough to further discuss the matter with Ms. Wann and City Attorney Chelsea Brannon. The motion was seconded by Alderman Tatum and unanimously approved by all Aldermen.

With no further business for discussion, Mayor Pro Tempore Bowering asked for a motion to declare the meeting adjourned. Alderman Strain made the motion, seconded by Alderman Jarvis and unanimously approved by all Aldermen. Mayor Pro Tempore Bowering declared the motion carried and the meeting was adjourned.
