INTRODUCTION AND ATTENDANCE

The first regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Wednesday, July 5, 2023 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. Mayor Hawkins Butler called the meeting to order and after a prayer led by Alderman Bowering and the Pledge of Allegiance led by Alderman Jarvis, the meeting proceeded as follows:

Director of Environment and Design Alan Hoops presented the architectural rendering for Sister Clare Hogan Hall at St. Francis of Assisi Catholic Church. After brief discussion, the motion was made by Alderman Jarvis, seconded by Alderman Strain, and unanimously approved by all Aldermen to grant approval of the architectural rendering and authorize the issuance of a building permit. Mayor Hawkins Butler declared the motion carried.

RESOLUTION BY THE BOARD OF ALDERMEN OF THE CITY OF MADISON, MISSISSIPPI EXPRESSING OPPOSITION TO SPLITTING THE MADISON AND RANKIN COUNTY CIRCUIT COURT JUDICIAL DISTRICT (DISTRICT 20) AND FOR RELATED PURPOSES

Mayor Hawkins Butler presented a Resolution for consideration by the Board to express opposition to a proposal to split the Madison and Rankin County Circuit Court Judicial District. She stated that all municipalities in this district are being asked to adopt a similar Resolution in opposition. After brief discussion, the motion was made by Alderman Strain to adopt the Resolution as presented. Alderman Jarvis seconded the motion and the vote was unanimous in favor of adoption.
