INTRODUCTION AND ATTENDANCE

The second regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, August 18, 2020 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. Present by telephonic conferencing was Alderman Tawanna Tatum. Mayor Mary Hawkins Butler, Alderman Mike Hudgins, and Alderman Warren Strain were absent.

Alderman Tankersely seconded the motion to approve the Consent Agenda and the vote was unanimous in favor of approval. Mayor Pro Tempore Bowering declared the motion carried.

<u>DEPARTMENT OF COMMUNITY DEVELOPMENT - SPECIAL EXCEPTION, VARIANCE, AND SITE PLAN FOR FULL MOON BARBEQUE - Approved</u>

Director of Community Development Kianca Stringfellow presented the request of AMAL Food, Inc for approval of several requests for the Full Moon Restaurant to be located on the southwest corner of Highway 463 and Crawford Farms Boulevard.

Approval was requested for a special exception for conditional use in a C-2 zoning for the construction of a drive through window at their restaurant, Full Moon Barbeque. Alderman Tankersely made the motion to approve the special exception as requested, seconded by Alderman Tatum and unanimously approved by all Alderman. Mayor Pro Tempore Bowering declared the motion carried.

Approval was also requested for a variance to allow for a decrease in landscape setback from 20' to 10' at this location. Alderman Peeler made the motion to grant approval of the landscape setback as requested, seconded by Alderman Jacobs and unanimously approved by all Alderman. Mayor Pro Tempore Bowering declared the motion carried.

Additionally, Ms. Stringfellow stated that all concerns had been address with regard to the site plan approval and the Planning and Zoning Commission recommended approval. Alderman Tankersley made the motion to approve the site plan for Full Moon Barbeque, seconded by Alderman Tatum and unanimously approved by all Alderman. Mayor Pro Tempore declared the motion carried.

<u>DEPARTMENT OF COMMUNITY DEVELOPMENT - CONCEPT PLAN, TISDALE FARMS - Approved</u>

Ms. Stringfellow presented the request of Owners Lee Hawkins and William Fincher for approval of a concept plan to development a 4-lot subdivision, two 15-acre lots and two 16-acre lots on property located at 0 Tisdale Road just north of North Ridge subdivision. It was noted that the preliminary plat for this development will be presented at the next Planning and Zoning Commission meeting in September. The motion was made by Alderman Peeler to grant approval of the concept plan. The motion was seconded by Alderman Jacobs and unanimously approved by all Aldermen. Mayor Pro Tempore Bowering declared the motion carried. Documentation relevant to this request is attached hereto and incorporated herein as **Exhibit O**.

With no further business for discussion, the motion was made by Alderman Peeler and seconded by Alderman Tatum to adjourn the Board meeting. The vote was unanimous in favor of approval and Mayor Pro Tempore Bowering declared the motion carried and the meeting adjourned.
