# MINUTES OF THE SECOND REGULAR MONTHLY MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF MADISON, MISSISSIPPI

#### September 20, 2022

#### **INTRODUCTION AND ATTENDANCE**

The second regular monthly meeting of the Mayor and Board of Aldermen of the City of Madison, Mississippi was held on Tuesday, September 20, 2022 at 6:00 p.m. in the Municipal Courtroom at the Madison Justice Complex. Those present in the Courtroom were Mayor Mary Hawkins Butler, Aldermen Sandra Strain, Tawanna Tatum, Janie Jarvis, Paul Tankersley, Mike Hudgins and Guy Bowering, City Attorney Chelsea Brannon, City Clerk/Director of Finance and Administration Susan Crandall and Chief Deputy City Clerk Lisa Winstead. Alderman Peeler was absent.

Mayor Hawkins Butler called the meeting to order. Members of the Boy Scout Troop 164 with Parkway Hills United Methodist Church, were welcomed at the meeting in partial fulfillment of requirements to obtain their Citizenship in the Community Badge. Following a Prayer led by Scout J. J. Tice and the Pledge of Allegiance let by Scout Parker McNeese, the meeting proceeded as follows:

#### COMMUNITY DEVELOPMENT DEPARTMENT

#### Variances for Front Yard Setback for Sign, Rigby Ridge of Mississippi,LLC -**Approved**

Community Development Director Kianca Guyton presented the request of Rigby Ridge of Mississippi, LLC for decrease in front yard setback from 20' to 10' for sign placement at their property located at 7708 Old Canton Road. The motion was made by Alderman Strain, seconded by Alderman Bowering and unanimously approved. Mayor Hawkins Butler declared the motion carried. ## <u>Variances for Front Yard Setback for Porte Cochere, Singh, 107 Homestead Drive - Approved</u>

Property owner Anshika Singh requested a variance to allow for a front yard setback decrease from 40' to 35' feet for a porte cochere on her daycare property located at 107 Homestead Drive. The motion was made by Alderman Jarvis to grant approval of this request. Alderman Tankersley seconded the motion and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried. Attached as **Exhibit V** are documents relevant to this request.

Amendment to Driveway Site Plan, Take 5 Oil Change - Approved

Following brief discussion, the motion was made by Alderman Strain to grant approval of the site plan amendment for the driveway at Take 5 Oil Change. Alderman Tankersley seconded the motion and the vote was unanimous in favor of approval. Mayor Hawkins Butler declared the motion carried. PUBLIC HEARING - REQUEST TO APPEAL, VARIANCE AT 1122 BENBROOK DRIVE - Remanded to Planning and Zoning Commission

Mayor Hawkins Butler declared the Public Hearing open for discussion regarding the appeal filed by Walter & Judy DeLoach of 1122 Benbrook Drive. Community Development Director Kianca Guyton explained that the Planning and Zoning Commission had previously denied the variance request to allow for an accessory structure side yard setback decrease from 10' to 1' for a patio replacement pergola. She requested that the matter be remanded to the Planning and Zoning Commission for consideration of a new request for the setback to decrease from 10' to 8'.

Mr. John Bane was present at the meeting and stated that he was speaking on behalf of thhis parents who live at 138 Mackey Drive and expressed concern that the structure was hanging over the property line into their back yard. He agreed to attend the next Planning and Zoning meeting in October to hear discussion and consideration of the new setback request.

With no further discussion, the Public Hearing was declared closed and Alderman Tankersley made a motion to remand the matter back to the Planning and Zoning Commission meeting at their meeting on October 10, 2022. The motion was seconded by Alderman Bowering. After unanimous approval, Mayor Hawkins Butler declared the motion carried. With no further business for discussion, Mayor Hawkins Butler asked for a motion to declare the meeting adjourned. Alderman Jarvis made the motion, seconded by Alderman Strain, and the vote was unanimous in favor of approval. The motion was declared carried and the meeting was adjourned.
